In the event a Schedule Contractor refuses to honor an order placed by you in accordance with this authorization, you should notify this office giving the facts and circumstances. Orders placed directly with GSA shall be placed in accordance with the Federal Standard Requisitioning and Issue Procedure (FEDSTRIP).

To receive an orientation relative to procurement from GSA sources, if necessary, you should contact the Customer Service Representative of your local GSA regional office.


